

NOTICE OF ERRATA TO THE DRAFT SOUTH DUBLIN COUNTY COUNCIL DEVELOPMENT PLAN 2022-2028

Errata to the Draft South Dublin County Development Plan 2022-2028 (Draft Development Plan) have been identified and are being published as part of the public consultation period to the Draft Development Plan on display between **Wednesday 7th July to Wednesday 15th September 2021**.

The 'Errata to the Draft South Dublin County Development Plan 2022-2028' should be read in conjunction with the Draft South Dublin County Development Plan 2022-2028. The errata have been assessed against the Strategic Environmental Objectives (SEOs) of the Draft Environmental Report (SEA) and against criteria set out in section 7.1 of the Natura Impact Report (NIR) prepared by Scott Cawley issued with the Draft South Dublin County Development Plan 2022-2028. A copy of these assessments is available for public inspection with the Errata Document.

The Errata Document can be viewed alongside the Draft Development Plan and associated documents which are on display up until **Wednesday 15th September 2021** during normal opening hours at:

- Tallaght County Hall and Clondalkin Civic Offices, by appointment (the need for appointment may change) and;
- Council libraries located in County Library Tallaght, Ballyroan Library, Clondalkin Library, Lucan Shopping Centre and North Clondalkin Library during normal opening hours and subject to relevant Covid restrictions in place during the consultation period.

Observations or submissions regarding the Draft Development Plan and/or Environmental Report and/or Appropriate Assessment are invited from members of the public and other interested parties. You can make an observation or submission up until Wednesday 15th September 2021 through one of the following two options only:

- In writing to **Senior Executive Officer, Forward Planning Section, Land Use Planning & Transportation Department, County Hall, Tallaght, Dublin 24.**

- Submissions/observations should include your name and address, a map (if required for identification purposes) and, where relevant, details of any organisation, community group or company etc., which you represent.
- Children, or groups or associations representing the interests of children, are particularly encouraged to make submissions or observations regarding the foregoing.
- Please be advised that all submissions received will be published online in accordance with the requirements of the Planning and Development Act, 2000 (as amended). You should ensure that no vexatious, libellous, or confidential information, including confidential information relating to a third party (in respect of which the third party has not, expressly, or impliedly in the circumstances, consented to its disclosure) is included in your submission. The Planning Authority reserves the right to redact any submission or part thereof that does not comply with this requirement. Please be advised that the submission will be published in full. Written submissions or observations with respect to the Draft Plan that are made to the Planning Authority within the period stated will be taken into consideration before the making of the Plan.
