Items discussed:

Item 1 - Footpath Repairs Orwell Park Estate

The group expressed concern that tree roots are pushing up footpaths in the estate causing trip hazards

Lorcan Brennan, Senior Executive Engineer, replied to the groups queries.

Commitment given:

 To prioritise the footpath repairs next year with a view to getting on the ground around March 2025, depending on the budget

Item 2 - Orwell Park Green, completion of lights on the green

The group expressed concern that the lampposts have been installed but the lamps haven't

Brendan Redmond, Senior Executive Parks & Landscape Officer, replied to the groups queries

Item 3 – Cycle Lanes Rossmore Road

The group expressed concern that the limited trial of the cycle lane only covers Rossmore Road and would like it extended to cover Orwell Road toward Templeogue Wood, to assess the impact on the parking at the doctors surgery and the school, the parking of buses and the pedestrian crossing. The group highlighted the issue of vans parking in the drop off parking bays and suggested the installation of signage to only allow drop off between certain times of the day and no parking other than that. The group also expressed concern in relation to the Spawell redevelopment and whether there would be cycle lanes included. The group enquired about the rent free bike scheme for the school.

Andrew O'Mullane, Senior Executive Engineer, replied to the groups queries

- To investigate the parking of vans in the parking bays and to include in their report
- To consider a study of the parking bays during the year
- To follow up on the progression of the rent free bike scheme
